We have 37 units comprising of 2, 3, and 4 bedroom townhouses. Included with these units are refrigerators, stoves, and hookups for a washer and dryer. Coin operated washers and dryers are available in the laundry room. Each household is entitled to 1 spot in the underground secure parkade.
